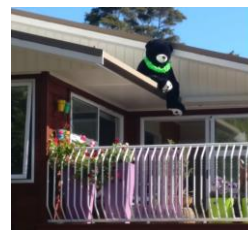




BUILDING SURVEYING CONNECT (3)

Fees Free

We have had some enquiries about Fees Free where fees are paid by the government. There is, however, an eligibility criterion that you will need to check out for yourself in the Fees-Free website (<https://www.feesfree.govt.nz/>). Registry has provided the following information to assist those interested but is not responsible for checking your eligibility so please do not email them to determine your status. Discuss with your manager.

1. Visit Fees Free Website <https://www.feesfree.govt.nz/>. Then enter your National Student Number (NSN) in the blank box provided. And click "Check". Learner NSN number is on the Proforma Invoices.
2. On the second page, click "Provider-Base Study".
3. On the third page, click "2020".
4. On the fourth page, choose the answer which meets your situation.
5. On the last page, there will be guidelines on how to create a [Statutory Declaration](#) form. Please follow these guidelines to complete the form if you meet the [eligibility criteria](#).
6. Once the statutory declaration form is signed and witnessed by authorised person (JP, Lawyer etc.). Please send the form to feesfreecheck@tec.govt.nz for processing.
7. You will receive a confirmation email from TEC. Once received please forward a copy to registry@futureskills.co.nz.

The New Zealand Certificate in Building Regulatory Environment Level 4 (60 Credits)

Part of my work involves developing programmes and some of you may have provided some feedback when I was packaging this one late last year and early 2020. We are really excited that this programme is going through NZQA approval processes with a likely approval date in late April/May with the first delivery pencilled in for late June.

This programme is designed for non-technical support roles in Councils like BCA/ TA administrators or those who provide administration support. It is a programme that aligns strongly with the Building Surveying L6 programme and is a steppingstone into it. It is delivered in much the same way with an In-Employment delivery mode and fully online this year. There are 10 face to face teaching days which can be done online over 20 weeks.
